TO THE HONORABLE JUDGES OF THE
COURT OF COMMON PLEASE OF LUZERNE COUNTY:
BE IT KNOWN, That the subscribers, citizens of the
Commonwealth of Pennsylvania, having associated themselves together for the purpose of organizzing THE SLOVAK
CATHOLIC FEDERATION, of Wilkes-Barre, Luzerne County,
Pennsylvania, and being desirous of becoming incorporated
agreeably to the provisions of the Act of General Assembly
of the Commonwealth of Pennsylvania, entitled, "An Act to
provide for the incorporation and regulation of certain corprovide for the incorporation and regulation of certain corporations," approved the 29th day of April A. D. 1874, and its supplements, do hereby declare, set forth and certify that the following are the purposes, objects and conditions of their said Association, for and upon which they desire to be incorporated:

incorporated:
FIRST: The name of the corporation shall be "THE SLOVAK CATHOLIC FEDERATION".
SECOND: The purpose for which the corporation is formed is the cementing of the bonds of fraternal union among the Slovak Catholics and the Catholic Societies of among the Slovak Catholics and the Catholic Societies of this country; the fostering and protecting of the interests of the Slovak Catholics and works of religion, piety, education and charity; the study and improvement of conditions in the social life of Slovak Catholics; the dissemination of truth; the encouragement, printing and reading of Catholic literature and the circulation of the same; the rendering of moral and financial assistance in the matter of education and improvement of needy Slovak Catholic children, in order that they may be prepared for good citizenship and better position in the world; and for these purposes the creating of a fund, the purchase of real estate, erection of schools, and the purchase and supply of books and libraries.

THIRD: The place where the principal business of said corporation is to be transacted is in the City of Wilkes-

Barre, State of Pennsylvania.

FOURTH: The corporation shall have the right to own

real estate for the purpose herein before related.

FIFTH: the corporation shall have perpetual succession by its corporate name.
